## **Pre-Approved Continuing Education for Body Art Profession Practitioners**

Class length (hours) are subject to change without notice from vendor

Pursuant to K.S.A. 65-1943, licensees shall complete five hours of continuing education, approved by the board, in infection control and blood-borne pathogens. If a renewal is submitted after the expiration of your license, an additional three hours of continuing education is required. Initial licensure requires applicants to submit eight hours of continuing education in infection control and blood-borne pathogens.

The total hours of continuing education must include infection control and blood-borne pathogen training.
