NOTICE: Upcoming Disinfectant Requirements 01/11/2019

Currently, Kansas law requires a disinfectant with bactericidal, virucidal, fungicidal and tuberculocidal activity for disinfecting instruments/surfaces that come in contact with blood or bodily fluids. In light of the fact that EPA-registered disinfectants that include tuberculocidal activity are not being manufactured after October 2018, the Board is in the process of updating Kansas laws to remove the requirement for a disinfectant with tuberculocidal activity altogether and add the requirement to disinfect the work station after each service. This update will prompt changes to proper infection control procedures for daily salon compliance.

Notice Effective January 1, 2019

Daily Salon Compliance: An EPA-registered disinfectant with demonstrated bactericidal, virucidal and fungicidal activity or a chlorine bleach solution shall be used to disinfect instruments and equipment in the salon. Workstations shall be cleaned (sanitized) after each service.

Blood Spill Procedure: Workstations must be disinfected. An EPA-registered disinfectant with bactericidal, fungicidal and virucidal activity must be used to disinfect the workstation. (Bleach solution or hospital grade disinfecting wipes/solution shall be used. No Clorox Disinfecting wipes/Lysol Daily wipes etc.)

*Once the new KDHE regulations go into effect, an EPA-registered disinfectant with bactericidal, fungicidal and virucidal activity must be used to disinfect the workstation after each service, not just if there is a blood spill.

10 Minute Initial Setup of Items that Remain Out for Entire Exam

These following items remain on the station for the duration of the exam. Do not set out tools and implements for any specific service. Candidates may also set up other items at their discretion, but at a minimum, must include those listed below.

- 1. Sanitizer for work surface.
- 2. Hand sanitizer.
- 3. Paper towels in labeled plastic bag.
- 4. Blood spill/first aid kit in a plastic container or plastic bag with contents visible and labeled in English containing:
- a. Bandages
- b. Anti-microbial
- c. Plastic bag labeled "biohazard"
- d. Protective gloves
- 5. One (1) or more freestanding waste disposal receptacle(s) on the floor underneath your assigned workstation for the exam.
- 6. Mannequin head #1 (do not drape).

K.A.R. 69-1-10 03/01/2019

69-1-10 Potentially disqualifying civil and criminal records; advisory opinion; fee.

- (a) Conviction of any felony may disqualify an applicant from receiving a license.
- (b) Civil records that may disqualify an applicant from receiving a license shall be any records of any court judgment or settlement in which the applicant admitted or was found to have engaged in conduct that would constitute a violation of any practice act under the jurisdiction of the board or any of the board's regulations. Those records shall not be used to disqualify an applicant for more than five years after the applicant satisfied any judgment or restitution ordered by the court or agreed to in the settlement.
- (c) Any individual with a criminal or civil record described in this regulation may submit a petition to the board for an informal, advisory opinion concerning whether the individual's civil or criminal record may disqualify the individual from licensure. Each petition shall include the following:
- (1) The details of the individual's civil or criminal record, including a copy of court records or the settlement agreement;
- (2) an explanation of the circumstances that resulted in the civil or criminal record; and
- (3) a check or money order in the amount of \$50.00.

Notice 05/17/2019

On May 13th, 2019, the Kansas Board of Cosmetology approved the use of lancets and scalpels by licensed cosmetologists and licensed estheticians when performing the beauty modalities of Milia lancing and Dermaplaning. These procedures are for esthetic purposes only and are permitted within the scope of practice as they are noninvasive and confined to the nonliving cells of the epidermis found in the stratum corneum layer of the skin. These practices do not alter, cut or damage any living cells as is prohibited in KAR 28-24-14 (5). Additionally, the use of the scalpel in Dermaplaning is only for exfoliation and hair removal and is not permitted to be used to remove calluses or skin blemishes as prohibited by KAR 28-24-14 (4).

Cosmetology and Esthetics are rapidly growing and ever-changing industries, and this major approval is a result of dedicated licensees, Board members and office staff working together to bring much needed changes to the Board's interpretation and application of current laws and regulations.
